ARRANGEMENT OF REGULATIONS

REGULATION

- 1. Citation
- 2. Restriction on importation of salt

IN EXERCISE of the powers conferred on the Minister of Trade and Industry by section 3 of the Control of Goods, Prices and other Charges Act, the following Regulations are hereby made —

Citation

1. These Regulations may be cited as the Control of Goods, Prices and other Charges (Restriction on Salt) Regulations, 2015.

Restriction on importation of salt

- 2. (1) A person shall not import salt unless it is in a minimum package of 100kg.
 - (2) Subregulation (1) shall not apply to -
 - (a) quantities of not more than 1kg of table or coarse salt imported for household consumption; and
 - (b) speciality salt.
- (3) For purposes of these Regulations, "salt" means pre-packed salt whether table salt or denatured salt and pure sodium chloride, whether or not in aqueous solution (sea water).
